

# Executive Order amending the Executive Order on deviations from the Act on Seafarers' Employment Conditions, etc., for Fishing Vessels 1<sub>1</sub>

## Section 1.

Executive Order no. 1006 of 15 August 2013 on deviations from the Act on Seafarers' Employment Conditions, etc. for Fishing Vessels, as amended by Executive Order no. 1344 of 21 November 2016 and Executive Order no. 1120 of 11 November 2019, is amended as follows:

**(1)** *The footnote* to the title of the Order is replaced by the following:

"The Executive Order contains provisions implementing parts of Directive 2019/1152 of the European Parliament and of the Council of 20 June 2019 on transparent and predictable working conditions in the European Union, Official Journal of the European Union 2019, no. L 186, page 105."

**2.** *The introductory part* is replaced by the following:

"Pursuant to section 1a(4), section 18d(1), section 55(1) and (4), section 57, section 64(1), section 70(1) and section 75(1) of the Act on Seafarers' Employment Conditions, etc, cf. Consolidation Act no. 1662 of 17 December 2018, shall be laid down by authority pursuant to section 1(1)(6) of Executive Order no. 261 of 23 March 2020 on the transfer of certain powers to the Danish Maritime Authority and on the right to complain, etc.

**3.** *Section 2* shall be replaced by the following:

**"Section 2.** Section 6(5), section 7(2)(3), section 8c, section 10(3), section 19(3)(2), and sections 73a and 74(1) of the Act shall not apply."

**4.** *Section 11* is replaced by the following:

**"Section 11.** The following provisions of the Act shall apply to the master:

- 1) Section 1(2),
- 2) Section 3(3) and (4),
- 3) Sections 3a - 3e,
- 4) Section 4(2),
- 5) Section 6(1)-(4),
- 6) Section 7(1), cf. section 39,
- 7) Section 8,
- 8) Section 10a(1) and (2),
- 9) Section 14(1), cf. subsection (3),
- 10) Section 15,
- 11) Section 18a,
- 12) Section 18b,
- 13) Section 18c,
- 14) Section 18d,
- 15) Sections 21, 22 and 24-26,
- 16) Section 27 with the deviation that follows from section 3 of this Executive Order,
- 17) Section 28,
- 18) Sections 29-30, cf. sections 35, 40 and 41, with the deviations that follow from sections 4-6 of this Executive Order,

- 19) Section 31,
- 20) Sections 32 and 34,
- 21) Section 33, cf. section 35, with the deviations that follow from section 6 of this Executive Order,
- 22) Section 55(1) with the deviation that follows from section 7 of this Executive Order and section 55(2),
- 23) Section 57,
- 24) Section 61, and
- 25) Section 64."

## **Section 2.**

The Executive Order enters into force on 1 July 2023.
